Whereas, the undersigned has been appointed as Returning Officer by The Registrar, Office of the Registrar Co-operative Societies, New Delhi vide office order no. F.47/1112/GH/East/RCS/Section-1/226 dated 28.06.2019 to hold the election of the Managing Committee of The Bhagwati Co-op G/H Society Ltd. Plot No. 1A, Sec-22, Dwarka, New Delhi.

Now therefore, I, Gaurav Saini, Returning Officer of The Bhagwati Co-Op G/H Society Ltd, hereby call a Special General Body Meeting of the aforesaid Society on 06.08.2019 (Tuesday) at 10:00 A.M. in the premises of The Bhagwati Co-Op G/H Society Ltd, for conducting the election for the One (1) post of President. One (1) post of Vice-President and Seven (7) posts of members of Managing Committee out of which Two (2) posts of the members of the Managing Committee are reserved for Women Candidate as per the provisions of DCS Act, 2003 enforced w.e.f. 01.04.2005. The term of the Managing Committee shall be for 3 (Three) Years.

The Nomination forms can be obtained free of cost from the Society premises itself on 27 & 28 July, 2019 from 11:00 A.M. to 03:00 P.M. Nomination forms duly filled-in along with the Security Deposit of Rs. 1000/- (Rupees One Thousand only) in Cash are to be handed over by Candidate or his/her Proposer or Secunder on the date and time mentioned above to the undersigned personally or to any other officer duly authorised in this behalf by the Returning Officer. A member is not eligible to contest election for two posts simultaneously. In case of member nominated for two seats, the member shall intimate his final choice to contest in one seat on the date of withdrawal, failing which his both nomination papers shall be deemed to have been cancelled.

Further the candidate, Proposer & Secunder should not be a Defaulter. A member is not eligible to contest for the election if he/she has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filling of the nomination. In case the candidate gets less than 1/6th of total votes polled, the security deposit shall be forfeited and such candidate shall be disqualified for contesting the election in that Society for a period of two terms of committee.

The list of eligible members of the aforesaid Society has been displayed at the Notice Board of office of the Society. Interested members can obtain a copy of the list of members from the Society on payment of prescribed fee, as per provisions of the Delhi Co-op Rules, 2007 (As amended from time to time).

Special Note

The meeting shall start on 06.08.2019 (Tuesday) at 11:00 A.M. in the premises of The Bhagwati Co-Op G/H Society Ltd., Plot 1A, Sec-22, Dwarka, New Delhi. The quorum of meeting will be observed for half an hour i.e. upto 11:30 A.M. and in case quorum of the meeting is not complete within half an hour, the meeting shall be adjourned for 15 minutes i.e. from 11:30 A.M. to 11:45 A.M. at the same place and thereafter the voting shall take place from 11:45 A.M. to 03:00 P.M. In the adjourned meeting, no quorum shall be necessary as per the DCS Rules, 2007.

The counting will start immediately after the polling is over and result will be declared immediately after completion of the counting.

Note: As per provision in the DCS Act 2003 & DCS Rules, 2007 the defaulter members of above said Society are neither eligible to contest the election nor are entitled to cast their votes. However, in case, if they make the payment of their amount in the default before the date of filing of nomination in the Society and produce the proof thereof before the Returning Officer, they will not be treated as defaulters and shall be allowed to contest the election.

If they show the proof of payment of default amount on the date of election they will be allowed to cast their votes. Further as per Section 35(7)(d) of DCS Act 2003, a person shall be disqualified for election of office in a committee "if he is an officer of a coop Society which has not got its statutory audit conducted within the statutory period prescribed in this Act".

It is notified that the Society has supplied a list of defaulter members which is available with the Returning Officer and displayed at the Notice Board of the Society and the Notice Board of the Returning Officer. Members are advised to check the list of defaulters to avoid any inconvenience at the time of filing of nomination form and also at the time of polling.

All the members of the aforesaid Society are also requested to bring the proof of their identification by way of Identity card issued by the Society or Driving License or Voter ID Card issued by Election Commission of India or any other related documents for their identification to facilitate the smooth conduct of election to avoid any inconvenience in their identification.
